Our Due Date is NOT necessarily the same as RFMU! Watch our left column for our due date each month. It is normally the 25th, but will be later if the 25th falls on a weekend or holiday.



Carbon monoxide (CO) is an odorless, colorless gas formed by the incomplete fuel combustion in an engine, furnace, or stove. Vehicles, camp stoves, charcoal grills, fuel-burning lan-

terns and generators can produce CO. Breathing CO in high enough concentrations will lead to death.

When people become sick the symptoms are similar to the flu, which can cause victims to ignore the early signs of CO poisoning.

The good news is that carbon monoxide poisoning can be prevented with simple actions such as installing a CO alarm, warming up your car outside your attached garage, and maintaining your fuel burning appliances.

The federal standard for safety is 9 ppm (parts per million) for an 8 hour period. At higher levels, your CO alarm will sound once the elevated level has been sustained over a certain period of time. If your CO alarm sounds, leave your home and call your local fire department to confirm.

Your natural gas furnace should be inspected every two years. Watch for excess moisture on windows, walls and cold surfaces. Watch for rusting on flue pipes. The natural gas flame should be blue, not orange or yellow.
